## **Results**

When referred for tests, we recommend you make a follow-up appointment.

Results will not be discussed over the phone for medicolegal reasons.

You are welcome to call the practice to find out if your results are available, and book an appointment with a doctor to discuss your results.

## **Telephone Access**

In general, phone consultations are not available, unless for a medical emergency.

GPs in the practice may be contacted during normal opening hours. If the GP is with a patient, a message will be taken and the doctor will call back when they have available time.

In an emergency your call will be put through to a nurse or doctor.

## **Medical Certificates**

Are legal documents and cannot be issued without actually seeing the Doctor and they cannot be issued retrospectively.

## **Fees and Billing Arrangements**

The GPs at our practice bulk bill all patients with a current Medicare/DVA card. If you do not have a Medicare/DVA card please enquire with the receptionist regarding fees.

## **Reminder System**

Our practice is committed to preventative care. Your doctor will seek your permission to be included on our reminder system and any State, Territory and/or Federal reminder systems/registers. We may issue you with a

reminder notice from time to time offering you preventative health services appropriate to your care. If you do not wish to be part of this system please let your doctor know.

## **Management of Health Information**

Your medical record is a confidential document. It is the policy of this practice to maintain the security of personal health information at all times and to ensure that this information is only available to authorized members of staff.
