Telephone Access

Under the current COVID19 pandemic, Medicare has made available Telehealth consultations for all patients.

To have a telehealth consultation, you book an appointment as normal and the doctor will call you at the appointment time.

In an emergency your call will be put through to a nurse or doctor.

Medical Certificates

Are legal documents and cannot be issued without actually seeing the Doctor and they cannot be issued retrospectively.

Fees and Billing Arrangements

The GPs at our practice bulk bill all patients with a current Medicare/DVA card. If you do not have a Medicare/DVA card please enquire with the receptionist regarding fees.

Reminder System

Our practice is committed to preventative care. We may issue you with a reminder notice from time to time offering you preventative health services appropriate to your care.

If you do not wish to be part of this system please let your doctor know.

Referrals

Our GPs are experienced at handling many medical concerns. At times they may refer you to a specialist for further help.

Referrals are legal documents and cannot be back dated under any circumstances.

Management of Health Information

Your medical record is a confidential document.
